# **Regional Coordinators Offer Support to WVU Preceptors**



The Office of Experiential Learning (OEL) is delighted to introduce two new additions to the team: Karen Famoso, RPh. and Joseph (Joe) McGlothlin, RPh. Karen and Joe are the first two regional coordinators for the OEL's pilot program to promote outreach and support to WVU preceptors.

Regional coordinators will serve as an extension of the OEL in areas of the state not in close proximity to the Morgantown campus. The coordinators will maintain regular contact with the preceptors in their areas to facilitate open lines of communication. Coordinators will visit rotation sites, disseminate

information, offer continuing education opportunities, and answer questions regarding the experiential learning program. They will also bring important information, ideas, and questions directly from the preceptors to the Directors of APPE and IPPE. The regional coordinator pilot program will focus on the Charleston/Huntington and the Wheeling/Weirton areas.

Karen Famoso is the Wheeling/Weirton regional coordinator. She currently serves as the Corporate Director of Pharmacy for Ohio Valley Medical Center and East Ohio Regional Hospital. She oversees pharmacy department operations at each location.

Joe McGlothlin is the Huntington/Charleston regional coordinator. He currently serves as the President of T & J Enterprises, doing business as The Medicine Shoppe Pharmacy. He also serves as a pharmacy consultant at Cabell Huntington Hospital Surgery Center.

# **Updated Rotation Hours Policy**

Beginning with the 2013-2014 academic year, an updated set of rules will take effect to better track student hours earned during each APPE rotation.

Each student must account for a minimum of 200 hours during each rotation block. These hours will be recorded by students in E\*Value using one of the following categories: rotation hours, holidays, school events, or absences. Rotation hours will consist of time spent onsite performing rotation-specific duties. Additionally, up to 10 hours (5% of the total rotation) of home preparation or reading offsite may count toward the minimum 200 hours.

<u>Please keep in mind that each rotation is designed to be a minimum of 200 hours. It is expected that many rotations will require more than 200 hours for successful completion of specific rotation requirements and learning objectives.</u>

#### IPPE Institutional Requirements on E\*Value

Following the tremendous success of offering IPPE Community coursework, hours logs, and evaluations through E\*Value this academic year, IPPE Institutional requirements will be completed using the E\*Value system beginning this upcoming Summer session. Students will upload their coursework electronically to E\*Value. They will also record their hours and complete their evaluations through the system. Likewise, preceptors will complete student evaluations using E\*Value.
